

## FREESTYLE OPTIONS AFFILIATE AGREEMENT

1. The Freestyle Options Affiliate Agreement sets out the Terms and conditions that apply to an individual or legal entity participating in Freestyle Options Affiliate Program.
2. This agreement is made between Freestyle Options, operated by BRYNMILL GROUP LTD, a company whose registered office is located at Oliaji Trade Centre, 1st Floor Victoria Mahe, Seychelles (thereinafter referred to as “Company”) and the Affiliate partner (thereinafter referred to as "you", "your" and/or “Affiliate partner”).
3. By opening an affiliate partnership account with Freestyle Options, using affiliate link and marketing materials provided by the Company, you confirm that this Agreement has been read, understood and accepted by you. This Agreement shall govern our affiliate relationship with you for [www.freestyle-options.com](http://www.freestyle-options.com) web-site, and it supersedes all previous agreements (if any).
4. We may change any of the terms of this Agreement from time to time, at our sole discretion, by either (i) sending you a notice by email or (ii) by posting the new version of the Agreement on our Affiliate Website. All changes to the Agreement will take effect 10 days after the date of posting or sending of any such notice (whichever is the earlier). IF ANY CHANGE IS NOT ACCEPTED BY YOU, THIS AGREEMENT SHALL BE TERMINATED. YOUR CONTINUED PARTICIPATION IN THE AFFILIATE PROGRAM FOLLOWING SUCH 10 DAY PERIOD WILL BE DEEMED BINDING ACCEPTANCE OF THE CHANGES.
5. You shall provide true and complete information to us when accepting this Agreement and promptly update us if it changes. You shall also provide us with such other information as we may reasonably request from time to time. All copyright material and trademark names and logos used for marketing purposes under this Agreement shall remain the exclusive property of Freestyle Options.
6. Affiliate partner remains solely liable for the content and manner of his/her marketing activities. All such marketing activities must comply with the law, regulation and provisions of this Agreement. Under no circumstance you or your associates or employees shall:
  - Use any marketing materials, which has not been approved by Freestyle Options. Place marketing materials on any online site or other medium where the content is malicious, discriminatory, obscene, unlawful, sexually explicit, pornographic, violent, misleading or targets any persons who are less than 18 years of age;

- Place marketing materials on any online site or other medium, the content of which may: infringe any third party's intellectual property rights, copy or resemble any page of the Freestyle Options sites in whole or in part.
  - Conduct any offline marketing activities without receiving prior written approval of the Company.
  - Send out emails or other electronic or phone communications, marketing, promoting or otherwise referring to us, our web-sites or containing our marketing materials, our trademarks or affiliate links, which can be qualified as Spam.
  - Place your own live trading account as a referred client under your affiliate account.
7. The CPA commissions apply on first time deposits only. The CPA commissions mean that the affiliate partner is paid according to the number of referred clients, registered on [www.freestyle-options.com](http://www.freestyle-options.com) web-site, who have deposited and generated the minimum required trading volume, as described below. The CPA commission plan does not apply to duplicate accounts (same client using different email) or fraudulent deposits, or deposits with the intention to chargeback after completing the trading volume requirement. Minimum deposit that qualifies Affiliate partner for CPA is 250 Euro, or equivalent in BTC. The client has to provide all required KYC documentation based on the regulatory requirements, to have his account approved.
  8. We apply 2 times turnover requirement meaning that if a client deposited 250 his total turnover has to reach 500 to qualify him as a depositor and generate CPA for an Affiliate partner. The monthly commission is payable on the 15th day of the following month. If the trading volume requirements are not met, the CPA commission will be rolled over and paid on the 15th day of the following month, when the trading volume requirement is met. Demo account or cash prizes won by clients in the course of participation in trading tournaments on demo accounts do not qualify an Affiliate partner for CPA commissions.
  9. Revenue share commissions are payable on all deposits of clients. Revenue share percentage is set as agreed between Freestyle Options and affiliate partner based on the performance.
